ORDER:

The High Court of Madras in its common judgment in the Writ petitions first read above had observed that "it can never be countenanced that the Government consciously intended to recognize a degree of M.A. through Open University System without the benefit of the foundation degree or the basic degree as equivalent to a recognized degree eventhough the University Grants Commission Regulations never contemplated such a course". "Therefore, recognition of a degree from the Open University System could be only on the anvil that such degree must be in accordance with the Regulations of the University Grants Commission and not in direct conflict with such Regulations. The expression in the Rules that for the purpose of eligibility of a person to be appointed as a Principal, he must be in possession of a degree of recognized University cannot be stretched to include "Master's degree" obtained from the Annamalai University by appearing at one time examination without the benefit of a previous 'first degree'."

- 2. The Supreme Court of India in its judgment second read above has opined that the High Court is correct in rendering the opinion in the manner it did in its judgment (i.e.) the Supreme Court of India has upheld the Judgment of the High Court of Madras dated 04.02.2008 in W.A. Nos. 1221 of 2005, 82 of 2006 and W.P.No. 36307 of 2004.
- 3. In view of the above judgments, the Secretary, Tamil Nadu Public Service Commission was addressed in the letter third cited to place the subject matter before the Equivalence Committee for its recommendations, as to whether a Post Graduate Degree obtained through Open University System without obtaining a Bachelor's Degree can be considered for appointment to Public Services.

- valence Committee above has stated that the Equivalence Committee in its meeting held on 16.11.2009 has resolved that "based on the Supreme Court Judgment, the Committee recommended that those who possess the P.G. Degree through Open University System without obtaining a basic degree cannot be considered as possessing a Post Graduate degree".
- 5. After careful examination, the Government have decided to accept the recommendations of the Equivalence Committee and accordingly direct that those who possess a P.G. Degree through Open University System without obtaining a basic degree cannot be considered as possessing a Post Graduate degree for appointment to Public Services.
