In the letter second read above, the Chairperson, Equivalence Committee / Principal Secretary to Government, Higher Education Department has forwarded the resolutions passed in the 5<sup>th</sup> Equivalence Committee meeting held on 07.01.2021 and 12.01.2021 under the Chairmanship of the Principal Secretary to Government, Higher Education Department, on the equivalence of Degrees offered by various Universities / Educational Institutions to the similar Degrees for the purpose of employment in Public Services and requested the Government to issue orders in the matter.

2. The Government, after careful consideration, approve the following resolution passed in the 5<sup>th</sup> Equivalence Committee meeting held on 07.01.2021 and 12.01.2021 under the Chairmanship of the Equivalence Committee / Principal Secretary to Government, Higher Education Department and direct that the following Degree offered by the Educational Institution viz., Ramakrishna Mission Vivekananda Educational and Research Institute, be equivalent to the similar degree mentioned therein for the purpose of employment in Public Services and also direct that no person shall be eligible for appointment to any service, class, category or grade or any post borne on the cadre thereof, unless he possesses such special qualifications and has passed such special tests as may be prescribed in that behalf in the special rules; or possesses such other qualifications as have been declared to

be higher than or equivalent to the said special qualifications or special tests, by the Government in consultation with the Committee constituted in the Government Order first read above and by the Government or by the appointing authority with the approval of the Government in other cases :-
