In the letter third read above, the Member Secretary (i/c), Tamil Nadu State Council for Higher Education, has forwarded the resolution passed in the 31st Equivalence Committee meeting (through circulation) held on 30.12.2024 under the Chairmanship of the Additional Chief Secretary to Government, Higher Education Department, on the Non-Equivalence of Degree viz. M.Sc. Medical Psychology awarded by Sri Ramachandra Institute of Higher Education and Research (Deemed to be University) to M.Sc. Psychology for the purpose of employment in Public Services and requested the Government to issue orders in the matter.

2. The Government, after careful consideration, approve the following resolution passed in the 31st Equivalence Committee meeting (through circulation) held on 30.12.2024, under the Chairmanship of the Additional Chief Secretary to Government, Higher Education Department and direct that the Degree offered by the Sri Ramachandra Institute of Higher Education and Research (Deemed to be University) be not equivalent to the Degree mentioned therein:-


